F.I.R.E. Service License Agreement

This license agreement outlines the requirements for the approved use of the registered F.I.R.E. Service “Certified Inspector” Logo and Name and any professional connection, assumed or implied, to be observed by the F.I.R.E. Certified Fireplace & Chimney Inspector. The Inspector enters this agreement having fully read and comprehending the following agreement.

The following terms are approved for use by all F.I.R.E. Certified Inspectors. The inspector’s representation on all documents whether written or electronic share read as follows. Both of these options can be followed by the inspector’s certification number.

- 1) “F.I.R.E. Certified Inspector”
- 2) “F.I.R.E. Certified Fireplace & Chimney Inspector”

As a F.I.R.E. Certified Fireplace & Chimney Inspector, your goal is nothing short of excellence. Your actions and professionalism applied in the field represent the Inspection Division of our Industry. This agreement represents your commitment to the industry as well as to your client. At no time shall you allow monetary interests to discredit your fellow Certified Inspectors, The F.I.R.E. Service, or to this Industry.

I enter this contract in full agreement with this belief and the knowledge of the repercussions of improper actions or practices.

I agree to hold harmless F.I.R.E. Service for any negligence, wrongful action or fraudulent activity provided or generated by myself, my employees and/or my company.

I further agree to conduct my business in a professional manner with the highest level of integrity and follow the F.I.R.E. Service Code of Ethics.

Any action or conduct deemed unethical or misleading by the Assembled Ethics Committee may result in the cancellation of your F.I.R.E. Certification and all rights and privileges related to such certification. This may include, but is not limited to the loss of all advertising rights, the logo and the term “F.I.R.E. Certified Inspector” or “F.I.R.E. Certified Fireplace & Chimney Inspector”. This disciplinary action may also include a posting of this action on the F.I.R.E. Service web site as well as written or verbal notification to any party requesting such information or affected by this loss of the F.I.R.E. Certification. Course and text fees are not redeemable if this certification is revoked as outlined by this agreement.

I agree to hold F.I.R.E. Service and any or all of its employees harmless for any loss of revenue or damage to my reputation resulting from this disciplinary action.

The "F.I.R.E. Certification", "Fireplace & Chimney Inspector" Certification requires attendance of all three FP courses and a passing score on the Certification Exam. It also requires a certification renewal every three years as based on your certification date. A packet will be sent to your last known address prior to your renewal date. Failure to notify F.I.R.E. Service of any changes in your mailing address, employment or contact information that resulting in financial penalties are the sole responsibility of the inspector. These penalties are out lined below. The Fireplace Investigation, Research & Education Service reserves all rights to determine professional requirements for this renewal process.

Late Fee Policy:


1. You will have 90 days (3 months) to complete and return your exam without penalty. Total amount due for re-certification \$ 75.00.
2. A late fee of \$45.00 will apply when returned within 120 days (4 months). Total amount due for re-certification \$ 120.00.
3. A late fee of \$165.00 will apply when returned within 365 days (12 months). Total amount due for re-certification \$ 240.00.

4. A late fee of \$ 275.00 plus testing under the current exam (proctor program) will be required when attempting to re-certify after 12 months. Total amount due for re-certification \$ 350.00 plus passing grade on current F.I.R.E. exam.

Note: Additional fee may apply for proctor programs and re-testing.
